# **Application Guidelines for financial support for obtaining JFS Standards**

#### **♦** Financial Support for obtaining JFS standards

We, Japan Food Safety Management Association (JFSM) will support the costs of obtaining JFS Standards, which are JFS-A/B/B Plus for Food Business Operators (FBOs) in Thailand.

JFS Standards are certification/conformity assessment of food safety management system developed in Japan and complied with CODEX HACCP requirements (= Japan HACCP regulation).

On top of financial support, JFSM will globally promote the applicant's food safety efforts or activities as best practices.

#### Terms and Conditions

✓ Eligibility:

FBOs in Thailand who are planning to obtain JFS standards (A, B, B Plus) through JFSM contracted Conformity Assessment Body<sup>1</sup> in Thailand.

#### ✓ Supported costs:

Costs related to obtaining JFS standards, which only limited to audit fees and/or registration fees to JFSM through conformity assessment body (excluding VAT).

✓ Support amount:

Eligible costs up to JPY100,000.

✓ Number of applicants:

4 FBOs.

✓ Preferential conditions:

In case of an excess of applications, they will be processed on a first-come, first-served basis according to the audit date.

- ✓ Application requirements:
  - 1) Applicants must be able to complete new registration of JFS standard by the end of December

2026. (this deadline would be flexible)

2) Applicants must be willing to cooperate with JFSM in promoting your food safety activities as best practice. (e.g. top management interview)

## ✓ Application period:

From 1<sup>st</sup> November, 2025 to 31<sup>st</sup> October, 2026.

Depending on # of the applicants, this application period could be flexible.

### ✓ Selection Process:

JFSM will complete the selection process based on the contents of your application and notify the applicant of the results.

#### ✓ Bank Transfer:

After confirming FBO's new registration has been completed, JFSM will make a bank transfer to the bank account specified by FBO.
