# 2. JFS-A/B Audit and Conformity Assessment Program

#### [JFS-A/B Audit and Conformity Assessment Program Document Ver.1.1]

Key changes in requirements are as follows:

1. Audit Company Recognition Committee

Requirements on Audit Company Recognition Committee\* are newly added in 2.5 "Audit Company Recognition Committee Regulations" of the JFS-A/B Audit and Conformity Assessment Program Document Ver.1.1.

2. Consultation and Audit Activities

The requirement concerning consultation and audit activities is newly added in 3.2 "Consultation and Audit Activities" that the person in charge of consultation is not allowed to become an auditor nor a reviewer of the same auditee.
