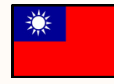

ICC (International Certification and Compliance Co., Ltd) is a globally accredited certification body with a local presence in Thailand. It is the first organization in the country authorized to conduct conformity assessments for the JFS standards, a food safety management system developed in Japan.



JFSM (Japan Food Safety Management Association) is the organization responsible for developing and operating JFS standards based on international requirements. Food safety management scheme has been adopted by over 3,600 sites in Japan, Thailand, and Vietnam.

In Thailand, both JFS-C and JFS-B are officially recognized by the Ministry of Public Health in Thai.



TQFA (Total Quality Food Association) is a Taiwan-based organization that operates TQF certification system, which is aligned with international food safety standards and supports the development of the food industry.

Together with JFSM, TQFA promotes automatic mutual recognition between the JFS-B Plus and the TQF-B Plus. This system allows food businesses in Thailand to expand the market in Taiwan.
